Effective Citizenship (ETH100)

Topic 001: Why this course?

We are taking this course because we want to learn the reasons why we are not doing well as a society. It will help us in realization, worry, planning, and sharing ideas with others on how to become a better citizen.

Topic 002: What makes effective citizenship?

First, we will learn what makes an effective citizenship. The first thing is a sense of responsibility which is an internal feeling about fulfilling the responsibility. The second point is empathy, which is feeling the pains of others and assessing how they are facing challenges in their life. The third point is patriotism which means loving your country and trying to make it better in every matter.

Topic 003: Why effective citizenship?

We will learn about the incentives and benefits of being an incentive citizen. Firstly, I will do better if I become an effective citizen. Secondly, it has benefits in this life as well as in the hereafter.

Topic 004: Effective citizenship: Duties of citizen

Every citizen has some duties to perform. The first duty is loyalty to the state and obedience to the Constitution. A citizen must follow the constitution in every aspect of life and be loyal to the state in all matters. Article 5 makes it binding on every citizen to be loyal to the state. The state has institutions that are legally bound to follow the constitution. Territories, objectives, and laws all can be changed within the limits of the Constitution."

Topic 005: Rights of citizen: Freedom of life and liberty

A citizen must be aware of the rights of other citizens. Article 9 ensures the right to life and liberty. It means one citizen cannot take the life of another citizen or injure him for whatever reason. One citizen cannot attack or harm another and cannot interfere in his personal life. Liberty and freedom cannot be taken away from any citizen.

Topic 006: Rights of citizen: Fair trial

Every person is entitled to a fair trial in which judges will make their decision about it. No institution will interfere in the process of a fair trial. If a person cannot afford a fair trial, then the Constitution ensures that he will be compensated so that he can have a fair trial. There cannot be a media trial before the final judgment.

Topic 007: Rights of citizen: Slavery

A citizen cannot be made a slave under any circumstances. Article 11 forbids all kinds of slavery and forced labor. A citizen cannot be forced to do labor for which he has not applied. It is against the constitution of Pakistan.

Topic 008: Rights of citizen: Freedom of movement

According to Article 15, all citizens have the right to move freely and settle in any area of Pakistan unless it is a prohibited area. All areas of all the cities are open for its citizens. Except the private houses and institutions where permission is required to enter. The idea is to bring the Pakistanis together.

Topic 009: Rights of citizen: Right of access to information

Article 19 ensures that every citizen has the right to access the information unless that information is prohibited. A citizen can apply from the relevant institution for the required information. However, any public interest or information that can be misused can be prohibited from public access.

Topic 010: Rights of citizen: Religious Freedom

Articles 20,21,22 ensures the right to choose a religion, preach it, and establish a religious institution. Nobody is bound to follow any religion other than his own. Admission should not be denied in educational institutions based on religious background. All citizens must have equal opportunities for freedom and participation.

Topic 011: Rights of citizen: Freedom to own and sell property

Articles 23 and 24 ensure that every citizen can buy or sell property anywhere at any time in the country. For the interest of special communities or areas, there can be some restrictions on the sale and purchase of the land or property because of its conflicting status. The constitution of Pakistan guarantees this right to its citizens so that the citizens can feel belongingness with their land and country and their relationship can become stronger.

Topic 012: Rights of citizen: Protection to language and culture

Article 28 ensures that every group having a distinct language or culture holds the right to promote their language and culture. The idea is to enrich diversity. It increases the positive qualities among the people and encourages critical thinking. This opportunity is to bring a feeling of belonging to the country and build a stronger connection with its country.

Topic 013: Rights of citizen: Protection from discrimination

According to Article 26, citizens are to be protected from being discriminated against based on language, religion, sex, or birthplace. The idea is to eliminate all forms of biases. The objective is to provide justice and fair competition to all. If the discrimination is not discouraged, it will generate demotivation and injustice in society.

Topic 014: Major challenges before an effective citizen: Poverty

Poverty can be the biggest problem before an effective citizen. It creates continuous tension and depression for a man suffering from poverty. It affects the behavior and attitude of a person. To deal with this, we should look for the people who are suffering from poverty from our relatives and then take some practical steps to help them. Make them feel that it is a temporary issue and that you can come out of it. When we alleviate poverty, it will bring benefits like happiness, less tension, and creativity.

Topic 015: Major challenges before an effective citizen: Illness

The ill person suffers from this as well as other people because of his illness. If he is the sole breadwinner of his household, he will not be able to go to work and thus his family suffers from his illness. Our role is to find out the ill person and practically and morally help him and his household. We can either financially support them or increase their motivation level. The blessings we get after fighting the illness include great relief and motivation.

Topic 016: Major challenges before an effective citizen: Ignorance

Ignorance is a growing problem in our country. Around 52% of people are literate and 48% are illiterate. This generates poverty in the society. The illiterate people lack understanding, and he is bound to others. He or she can be exploited if people are aware that you can not read or understand things. The contribution made by an illiterate person is much less than compared of a literate person. The standard of living gets improved for a literate citizen and explores more opportunities in society.

Topic 017: Major challenges before an effective citizen: Injustice

The injustice in our society is on many levels. One level of judicial injustice. It takes years to decide the courts. Another level of injustice is economic injustice. In our country, there is a great difference between the salaries of the private and public sector and people are unable to afford their basic needs. The third level is social justice. In a family, some people are preferred over others and are not treated equally. Society can not flourish unless the injustice is removed from it.

Topic 018: Attributes and personality traits of an effective citizen: Truthfulness

When a person is truthful, people trust him. Similarly, if the state institutions do not have truthfulness, then the citizens lose their trust over them. They know that these institutions cannot provide them with justice and rights. We as a citizen, need to make truthfulness at our level. We ourselves first need to be truthful and then make this virtue common among our people of concern. Society will ultimately progress if all its citizens abide by the virtue of truthfulness.

Topic 019: Attributes and personality traits of an effective citizen: Politeness

Politeness creates harmony in the society. People cannot relate to harsh and strict behavior. Citizens respect the other citizen if he is polite and sober. It is necessary that the public dealing of all aspects must be done with politeness and sympathy. It does not mean that you must be polite about the wrongdoings of people. Politeness generates healthy communication among the citizens and new opportunities of collaboration are developed.'

Topic 020: Attributes and personality traits of an effective citizen: Learning

Learning is a habit. We must be trained to enjoy the learning. New learning creates joy, and it helps to improve the personality. When you learn, then you try to teach. It generates the self-motivation and self-fulfilment that he has taught something positive to others. It also generates new ideas and opportunities for growth in society. But if we don't learn, we cannot develop the country and become effective citizens.

Topic 021: Attributes and personality traits of an effective citizen: Positive Thinking

A citizen must be positive about himself. He must trust his abilities and know that he can contribute to his society. He or she must be positive about the others as well. People have good intentions and take the information from others as they are saying to them without any negative thoughts. The society becomes positive when its citizens are positive. It grows and flourishes collectively which ensures that the future is bright. Positive thinking generates positive energy and nothing can stop its development process.

Topic 022: Attributes and personality traits of an effective citizen: Flexibility

To become an effective citizen, we need to develop the quality of 'flexibility'. Behaviors that indicate your adaptability may attract others towards you, which will lead to strong interpersonal relationships ultimately creating an environment in which everybody is willing to help each other out.

Also, strictness and reluctance to compromise cultivate a narrow one-man world. In addition, being flexible means the acceptance and realization that there is a possibility of making a mistake. Thus, it drives self-correction or helps in correcting oneself. This also helps in correcting others because this flexibility reflected in one's behavior makes one able to process the mistakes of others. As a result of this, progress is made in the society.

Topic 023: Attributes and personality traits of an effective citizen: Kindness

To be effective citizens, kindness holds vital importance. This virtue that is commonly tied to softness and politeness demonstrates the profound impact of our behaviour on the social fabric and relationships. When we treat others with kindness, our own performance and standard of life become better.

The regular expression of empathy and compassion strengthens a caring community spirit. In this way, the environment becomes congenial. The positive encounters, inciting from kindness, give positive energy to the society. And it creates a better mood for people to work with. As a result of this, this good mood of a person generates good performance both in oneself and the others around him.

Topic 024: Attributes and personality traits of an effective citizen: Respectfulness

A good citizen can never afford to be disrespectful to other people. In essence, respect for others/ respectfulness lies at the very heart of any well-functioning community.

The relationships are built based on whether we anticipate respect from others and whether they provide it. Since the expectation of respect from others and its actual fulfillment leads us to discuss matters more confidently even in difficult situations, hence, this element of mutual respect is vital for building a confident, happy, and progressive society. It builds confidence in the individual you respect and builds confidence in yourself as well.

One can be respectful by knowing the positive aspects of the other person and by acknowledging one's own weaknesses.

Topic 025: Attributes and personality traits of an effective citizen: Humility

Humility is a vital character one must have to be an effective citizen. This helps in learning. Humility is the opposite of pride and arrogance—the traits we all dislike because they prevent us from developing ourselves further through reflecting on and accepting our own mistakes. Humility is not only a learning resource but also, provides the essential basis of building social relationships. Practicing respect, kindness, compassion, and basically anything that showcases positive values makes our relationship with others even stronger. So, modesty or humility is a value or virtue necessary to be connected to other people.

The process of recognizing of our limitations is VERY important for humility development, as well as the fact that we should recognize the different qualities and strengths that others have.

Topic 026: Attributes and personality traits of an effective citizen: Honoring commitments

Without confidence in commitments getting honored, no nation can be built. Making and keeping promises is the fundamental thing in nation-building. It is impossible to lead a happy life, accomplish something, or progress if there is no guarantee that commitments will be upheld. Countries that have a high proportion of the citizens who fail to fulfill their commitments, create an atmosphere of mistrust, which in turn, slows down progress, and pave the way for negativity to grow. It should also be clear that every commitment is important. If a commitment is betrayed, it is essential for an individual, at the same time, to confess his failure, show sincere remorse, and feel regret thoroughly. Next, they need to make a firm decision to take a different stance to be able to honor future commitments.

Topic 027: Attributes and personality traits of an effective citizen: Fulfilling trust

Fulfilling trust and responsibilities is the basis for every person who wants to be productive and effective citizens of a society. An implied responsibility which is often disregarded relates to the task of keeping trust. This implied commitment to fulfilling trust holds significant importance. This includes fulfilling the duties and expectations we have been entrusted with through our family roles, in organizations, and as responsible citizens in a country. The entire life revolves around trust. Life cannot go on in any society until people trust each other. And this trust is the result of fulfilling commitments. Trust is the basis for social interaction and society functioning. Society cannot truly function without its members having the confidence to depend on each other. Trust is gained by performing these responsibilities regularly.

Topic 028: Attributes and personality traits of an effective citizen: Self-criticism

You need to find the shortcomings and negative habits of your personality and try to improve yourself. It makes you grow as an individual. It creates real confidence and helps you improve your personality to become a better citizen. A self-critical person often finds less time to find negativities from other people. He focuses on his personality rather than to be in the pursuit of finding the mistakes of other citizens.

Topic 029: Attributes and personality traits of an effective citizen: Art of saying NO

In life, there are instances where a man needs to say no to others. He must learn the art of saying NO to others. Negative events in life make us strong. But you must try to find a positive aspect even from a negative thing. Whenever you have to say no to any other person, you must say it properly. You can give counter suggestions and provide the solution to his or her problem in a different manner. It must be taken as an opportunity to light the positivity in other people.

Topic 030: Attributes and personality traits of an effective citizen: Empathy

Empathy is feeling others by placing himself in his situation. Do not try to judge the problems of others with your eyes. Instead, try to place your feet in his or her shoes and then try to understand his behavior. If you can develop with quality, it will generate pure feelings of care and sympathy in you. For example, if you had a problem in your past, you must think that if that event had happened with the other person, how he would have reacted? In this way, you can empathize with others.

Topic 031: Attributes and personality traits of an effective citizen: To be law-abiding

It is the key to a successful society. The laws are made for the safety of its citizens, and nobody will feel unsafe. Laws ensure the safety and peace of the country. If the citizens are not law-abiding, it will cause a destructive society as every citizen will do as he wants. There will be no one to stop him from harming others. That is why laws ensure equal protection for all its citizens. The concept of punishment makes sure that citizens fear the consequences of doing an unlawful activity.

Topic 032: Attributes and personality traits of an effective citizen: Avoiding Arrogance

This topic will discuss the issues or flaws that should be eliminated to become an effective citizen. One of the biggest issues is of Arrogance. An arrogant person cannot be a good team member because teamwork demands people to respect each other, acknowledge others good attributes, and help each other and an arrogant person cannot learn as it hinders learning and teamwork. Overcoming arrogance involves recognizing it as a form of pride and deception, understanding that everyone has flaws and strengths. By developing humility and respecting others, individuals can foster a spirit of learning, teamwork, and societal contribution. This shift towards humility and realistic self-assessment is essential for personal growth and effective citizenship.

Topic 033: Attributes and personality traits of an effective citizen: Avoiding Rudeness

Rudeness is another issue that every effective citizen should avoid as it creates negativity in oneself. When a person gets rude, he becomes negative that leads to negative emotions and negative energy is developed. Hence his work, his efforts or his achievements are affected. Effective citizens must avoid rudeness as it breeds negativity, affecting personal well-being and disrupting social harmony. Rudeness creates a hostile environment, minimizing productivity and happiness. One of the important questions is that “Is strictness always rudeness?” because most people think that to get work done or to get disciplined, rudeness is necessary. Being strict is not always rude; it is about being serious when needed. But if you are always angry and disrespectful, people will not listen. Because constant anger and belittling of others characterize rudeness, leading to isolation and ineffectiveness. To be an effective citizen, one must avoid rudeness and opt to be respectful and firm for a positive and better environment and being effective.

Topic 034: Attributes and personality traits of an effective citizen: Avoiding enjoying being praised

This topic will address another big issue that is self-praising as it is a weakness of a person that he likes to be praised. He feels happy when people praise him. If it is within a limit then it is quite natural but if a person is going beyond the limits, then it is a deceit. Self-praise is a problem because it can lead to dishonesty and a false sense of superiority. It creates arrogance as a person is not ready to face the reality or to listen the truth. When people love being praised too much, they become vulnerable to manipulation and may make decisions based on false information. It stops possibilities of improvement as he will always listen to the things that are being praised and is not ready to listen the flaws. This obsession with praise stops personal growth and improvement as individuals ignore their weaknesses. Leaders who are constantly praised may misuse their power and make wrong decisions, harming society's progress. It is crucial for everyone, especially leaders, to avoid this habit and focus on real feedback for true development.

Topic 035: Attributes and personality traits of an effective citizen: Avoiding exaggeration

Exaggeration has become a common trait that distorts truth by making things seem more significant than they are. It is very much prevalent in our society leading to a culture where exaggeration feels necessary

for attention or validation. We need to understand the fact that exaggeration is a lie and deceit which is not true and ultimately people get used to it. This habit eliminates honesty and hinders genuine communication. In a society where exaggeration is practiced a genuine message will never impact because people are used of doing exaggerations. They do not like any story until it is exaggerated. This will result in loss of true information and justice, and they will not even like to listen the facts or reality. So, to be an effective citizen, we must avoid exaggeration and value truthfulness and discourage exaggerated information in society to preserve integrity and foster honesty, fairness, and the importance of truth in our interactions and decision-making.

Topic 036: Attributes and personality traits of an effective citizen: Avoiding egotism

Egotism, focusing solely on oneself, leads to a distorted view of reality and prevents personal growth. An egotist person is not realistic as he often seeks validation through self-praise. He cannot see beyond his nose. He cannot see good in others and lives in a deceit life thinking that world revolves around him. Consequently, it distances them from genuine connections and feedback. This self-centred behaviour does not allow them to become an effective citizen, as they fail to see beyond their own perspective, and they lack humility. They do not realize that others are not interested, and they are not getting impressed by their false information. Hence, it is crucial for individuals to recognize and reduce egotistic behaviours to foster meaningful interactions and contribute positively to society.

Topic 037: Attributes and personality traits of an effective citizen: Avoiding unnecessarily humble

Being unnecessarily humble also becomes a problem as it may come across as fake or insincere. Exaggeration of everything is bad as overly humble behaviour can appear fake and one might lose his self confidence. However, humbleness is valuable for personal growth and fostering positive relationships, but it should not be exaggerated. Effective citizens must maintain a balanced personality to encourage learning and collaboration, acknowledging achievements without excessive criticism or false modesty as it can hinder personal development. They must contribute positively to society by being genuine and promoting a healthy balance of humbleness and self-confidence.

Topic 038: Attributes and personality traits of an effective citizen: Avoiding taking things lightly

Taking things lightly, is another important problem or weakness that hinders society growth or success as it kills seriousness. When we work together, we come across that we work less and waste time a lot and we lack seriousness in our work. The reason is that people do not enjoy their work. In the next step, you will learn how to reduce bribery. To end bribery, people must understand its negative consequences. Public officials who make important decisions need to act with impartiality and justice. Holding individuals accountable for bribery deters corruption.
